SPRING 2025 Responsible Conduct of Research (RCR) Training Sessions

Research Compliance is pleased to announce our Spring 2025 course dates for Responsible Conduct of Research (RCR). The topics are presented by content experts and fulfill the National Institutes of Health (NIH)* and NSF requirement for formal instruction for those obtaining career development, research education, and dissertation research grants. Researchers and research personnel not seeking NIH or NSF funding can still benefit from the training to learn the principles of RCR.

The sessions are presented in a case study format highlighting RCR principles in a didactic session where learners can participate and benefit from peer-to-peer experiences and learning. Completing the pre-requisite CITI Program (citiprogram.org), as well as RCR coursework, is required. After attending the 12-series training sessions, attendees will receive a *Certificate of Completion*. The training sessions will be from 9:00am-10:30 a.m. and will allow instruction in two content areas during each session.
