
# **ORUSH**

### **Advancement of Medicine**

I have continued to work with civil rights organizations, such as the American Civil Liberties Union and others in different states, as an expert in addressing constitutional violations and civil rights violations for children and adolescents who are incarcerated. I have continued to lecture on this topic, as well. I



continued to lecture and supervise our fellows and residents in a consistent fashion. Funding has allowed me to participate in a variety of unfunded educational endeavors, including taking fellows to different schools so they can learn more about school assessments and children with special needs and how they are cared for. I have continued representing Rush in the news, radio, television, and print locally and nationally.

I have continued to present locally at Easter Seals, community mental health centers and high schools. Our fellows rotate at Sonia Shankman Orthogenic School, a therapeutic day school where I have worked for years. Each year, I present with the school's medical director. I continue to attend national conferences and just stepped down from major committees at the American Psychiatric Association. I have continued advocacy work for children, including in Washington, D.C.

The funds from my endowment have helped significantly in giving me the time for administrative interventions and expanding the Division of Child and Adolescent Psychiatry, particularly under staffing constraints. The division now includes the Autism Assessment, Research, Treatment and Services, or AARTS, Center; the Rush NeuroBehavioral Center, or RNBC; two outpatient child and adolescent program locations; and the Child and Adolescent Psychiatry Fellowship.

#### **Grants**

I am the principal investigator on the Institute of Education Sciences grant "Validation of a Spanishlanguage social reasoning assessment for Spanish-speaking English language learners" through



December 2026 and was a co-investigator on another Institute of Education Sciences grant "Webbased assessment of social-emotional skills in middle school" through June 2024.

Four grants are presently under review for federal or private funding.

The AARTS Center has 11 ongoing grants, including seven federal or public and four private or philanthropic.

The RNBC is expanding its social-emotional research portfolio to include sleep research. This is reflected in a series of new grant proposals the center recently submitted and in its analysis of a recently concluded pilot longitudinal study. That study evaluated the impact of early school start times on early elementary students. Our sleep-related research has been conducted closely with departmental colleague **Stephanie Crowley**, **PhD**, a leader in adolescent sleep science.

The research team at RNBC is also actively involved in community partnership research opportunities with Heart of the City. This organization provides youth development services, along with high-quality soccer training for all levels, with an emphasis on providing out-of-school activities for families from marginalized communities. RNBC advises on the delivery of social-emotional learning in Heart of the City's programs and may soon expand to include research on their athletes and concussions, and elite athletes and sleep. The research team will also partner with Rondout School District 72 on upcoming sleep initiatives in academic year 2025-2026 and will continue to engage the district in upcoming research projects.
